## Safeguard Young People Programme 2021 Annual Report



The regional Safeguard Young People (SYP) programme empowers adolescents and young people aged 10 to 24 years to protect themselves from sexually transmitted infections (including HIV), early and unintended

pregnancy, unsafe abortion, early marriage, gender-based violence (GBV) and other harmful cultural practices. In achieving this end, the SYP programme promotes gender-equitable norms, an enabling legal and policy environment,

comprehensive sexuality education (CSE), and high-quality adolescent and youth-friendly sexual and reproductive health (AYFSRH) services.



### Safeguard Young People Programme Annual Report 2020

When it became clear that the COVID-19 pandemic was set to change life as we know it, the SYP regional team employed several different strategies to ensure quality action at regional and country levels. As it was essential to align with the African Union Commission (AUC) on Youth and COVID-19, the programme worked in partnership with relevant youth networks and organizations and began applying the 3 Ps: Preventing, Providing and Protecting.



## The Safeguard Young People Programme Phase II Report 2017-2019



SYP has been implemented by UNFPA and its regional and national partners since November 2013 in eight Southern African countries. Since then UNFPA successfully achieved a number of country and regional results in two Phases, which are detailed in this report.



#### Our Journey



These Safeguard Young People best practices have been implemented for periods varying between three and six years. With a clear description of strategies selected, lessons learned, what worked and what didn't work,

the step-by-step implementation processes documented here allow these best practices to be scaled up in different settings.



### Safeguard Young People Programme Annual Report 2018



The year 2018 marked the fifth year of the Safeguard Young People (SYP) Programme, it was also the second year of its Phase II, 2017-2019. SYP is UNFPA East and Southern Africa youth flagship programme, supported

by the Swiss Agency for Development and Cooperation (SDC) and other development partners according to the different countries of implementation.

Now, exactly in the middle of Phase II, we look back and we also look forward – to what we have already accomplished, often exceeding expectations, and to what we need to do to meet our targets for 2019.



## Safeguard Young People Programme Annual Report 2017



The year 2017 brought renewed energy to young people's sexual and reproductive health in Southern Africa as UNFPA embarked on Phase 2 of one of its flagship programmes, Safeguard Young People (SYP). SYP's holistic

approach is unique in joining the dots to address the SRHR needs of young people –including policy and laws, education, health and, critically, the agency of young people. The synergy of shared goals enabled SYP and its partners to work more efficiently and exceed annual targets in certain areas.

and reproductive rights. The assessment resulted in the development of a harmonized regional legal framework, which translated international and regional legal provisions into useful strategies.




#### Framework for the Harmonization of the Legal Environment on Adolescent Sexual and Reproductive Health in East and Southern Africa

This video targets parents, leaders and policymakers, explaining the different ages of consent to marriage, sexual activity and access to SRHR services, and what to take into consideration when working on relevant





where much of the youth-led accountability takes place.




## Remote Methods For Engaging Adolescents And Young People In Research

CSE is central to children and young people's well-being, equipping them with the knowledge and skills they need to make healthy and responsible choices in their lives. This body of work assesses a range of factors to paint a picture of the global status of CSE, including laws and policies, coverage, curricula, delivery and enabling environment. It includes case studies and data at the regional and national levels as well as specific lessons learned.



## International technical guidance on sexuality education: An evidence-informed approach (2018)



The International technical guidance on sexuality education is a technical tool that presents the evidence base and rationale for delivering comprehensive sexuality education to young people in order to achieve the global

Sustainable Development Goals. The guidance identifies the characteristics of effective comprehensive sexuality education programmes, recommends essential topics and learning objectives that should be covered in curricula for all learners, and outlines approaches for planning, delivering and monitoring comprehensive sexuality education programmes.

This report is a consolidated summary and analysis of the status of comprehensive sexuality education for teacher training in 21 countries in the East and Southern Africa region.




## UNFPA Operational Guidance for Comprehensive Sexuality Education. A focus on Human rights and Gender (2014)



This Operational Guidance sets out UNFPA's framework for Comprehensive Sexuality Education (CSE), which is one of five prongs to UNFPA's Adolescent and Youth Strategy. This document guides UNFPA's support

to governments and other partners as CSE programmes, both in and out of school, are designed, implemented and evaluated. Building on current standards, it outlines steps to identify priorities, implement actions and evaluate outcomes – providing country-specific examples, tools for programme managers and technical advisers.



## The Evaluation of Comprehensive Sexuality Education Programmes. A Focus on the Gender and Empowerment Outcomes



This report represents an important milestone in our understanding of advances in the field of comprehensive sexuality education evaluation. It offers an extensive review and analysis of a wide range of evaluation studies of different

comprehensive sexuality education programmes, at different stages of development and from different contexts and settings across the globe. It enriches our knowledge of new methodologies, available questionnaires and instruments that can be applied in future assessments and evaluations, most particularly to measure the gender empowerment outcome of comprehensive sexuality education programmes. It addresses the adaptation of the methodology to various contexts and age-specific groups of young people and children







## Regional module for teacher training on comprehensive sexuality education for East and Southern Africa (2015)



The module was developed as a resource to support pre–service training of teachers for the delivery of school–based sexuality education in East and Southern Africa. Designed for trainers who are delivering pre–service

training on sexuality education in the region, the material provides a core set of lesson plans to equip teachers with the basic knowledge and skills necessary to deliver effective sexuality education in the classroom. While the material is focused on training teachers for school—based sexuality education, the material can be adapted to out—of—school environments. Further, given the importance of local realities within which sexuality education is being delivered, trainers are encouraged to further adapt the lessons to their particular country contexts where possible.

Young Persons with Disabilities: Global Study on Ending Gender-based Violence and Realizing Sexual and Reproductive Health and Rights contains new qualitative, global research. This study provides an analysis on

the situation of young persons with disabilities concerning discrimination and gender-based violence, including the impact on their sexual and reproductive health and rights. It also provides an assessment of legal, policy and programming developments and specific good practices in service delivery as well as best-standard prevention and protection measures. Finally, policy and programming recommendations are provided to assist in greater promotion of the rights of young persons with disabilities, with a particular emphasis on preventing and responding to gender-based violence, and realizing sexual and reproductive health and rights.



Women and Young Persons with Disabilities Guidelines for Providing Rights-Based and Gender-Responsive Services to Address Gender-Based Violence and Sexual and Reproductive Health and Rights for Women and Young Persons with Disabilities (2018)

The AMAZE videos are a core component of SYP's digital solutions, providing short animated CSE videos aimed at young adolescents 10-14 year olds that align with the standards of the International Technical

Guidance on CSE covering topics under themes such as Puberty and Menstrual Health, Gender Identity, Personal Safety, Sexual Orientation, Healthy Relationships & STIs, Pregnancy and Reproduction. To date SYP has developed a playlist of 29 videos.



#### Variations in the Menstrual Cycle: Get to know your cycle



This video reviews the stages of the menstrual cycle and talks about how it can vary in terms of how long it lasts and how often it comes, especially when girls are first getting their periods, which is totally normal.



## Blessers: Older Partners and Transactional Relationships



This video explores the issue of relationships particularly between older men and girls that are sexual and transactional, often referred to as "blesser-blessee" relationships in parts of South Africa. The video features two sisters

discussing the younger sister's friend, who has recently taken up a relationship with a much older man who has been providing her with gifts.



#### **HIV Treatment Adherence**



In this video, we learn about HIV treatment adherence from Karabo, who has just done a presentation about living with HIV at school,

for which her cousin expresses appreciation. Key points about adherence are relayed in her conversation about the presentation with her older sister (who is also HIV positive), including what adherence means, tools for adhering to HIV treatment, and the benefits of adhering to it.


#### View more AMAZE videos





The Let's Talk! Campaign invites the people of Eastern and Southern Africa to engage in conversations about early and unintended pregnancy. The campaign encourages intergenerational dialogue and community

activation as a means to foster change across all levels of society, through three main pillars. 1. Health:Advocating for increased access to sexual reproductive health services (including contraception) for all adolescents and young people, without judgment or discrimination. 2. Education: Ensuring that adolescents and young people have access to good quality comprehensive sexuality education to equip them to make informed life choices and prevent early and unintended pregnancy. 3. Rights: Ensuring that all adolescents and young people know their rights and are empowered to make decisions regarding sexuality, health and education that will allow them to reach their full potential. The webpage contains many helpful resources, including the radio drama series and videos of the regional champions.

## UNFPA and the Climate Crisis. Strengthening Resilience and Protecting Progress within the Decade of Action



The UN Secretary General has stated that, "The Decade of Action will see special amplification around three challenges: eradicating poverty and reducing inequality; driving climate action and supporting a healthy planet; achieving

gender equality and the empowerment of women and girls." Each of these is central to the ICPD and UNFPA's mandate. For UNFPA, limiting the impact of climate change on the achievement of our transformative results and increasing the resilience of people and systems to cope with climate change.

In 2019, UNFPA organized an International Symposium on SRHR, Gender and Climate Change Resilience to share knowledge and identify programmes to reduce the impacts of climate change and build the resilience of communities in vulnerable settings. The resulting Future Africa Call to Action outlines both the impacts of climate change on the achievement of universal access to sexual and reproductive health and rights and the contributions that the ICPD community can make to building climate resilience. It puts forward a programmatic framework with four pillars connecting the promise of ICPD25 and the achievement of climate change adaptation and resilience.

## Sexual and Reproductive Health and Rights in National Climate Policy. A Review of 50 Nationally Determined Contribution Documents (2021)



National climate policies play a key role in determining responses to climate change, including plans to build adaptive capacity and resilience. An evaluation of national climate policies with a specific focus on health,

including sexual and reproductive health and rights (SRHR) issues, can provide important information on gaps and areas of potential improvement to ensure healthy and resilient communities.

UNFPA, in collaboration with Queen Mary University of London, undertook a review and systematic content analysis of SRHR references and related thematic areas in NDC documents for 50 countries.

The review aimed to describe how SRHR is currently represented in NDC and related policy documents to help determine how climate policy can better reflect SRHR.


